Greetings,

Thank you for your patience while staff completed this public records request. Below, please find the requested information.

1. Total usage of Auditory Tactile Interface also known as the Sip 'n Puff for the 2022 General Election as well as the 2020 General Election.

There is no documentation for this request, there are ADA accessories for the ICX Primes for in-person voting in Washoe County available to ADA voters. However, use of these features are not tracked and therefore no documentation exists.

2. Total usage of "large type" for the visually impaired for the 2022 General Election as well as the 2020 General Election.

There is no documentation or reporting if people use the large font option while using the ICX Primes for in-person voting in Washoe County. There were no requests for large type ballots for the 2020 or 2022 election and therefore no documentation available for this request.

3. Please furnish the 2022 EAV Survey required by the Secretary of State.

The survey on behalf of Washoe County has been submitted to the state within the required deadline, however the portal is no longer available for the county to access as the deadline to submit has closed. The survey has not been published by the U.S. Election Assistance Commission and is therefore not available until they publish the report.
