MOTION FOR RECUSAL OF JUDGE

COMES NOW the Plaintiff, Robert Beadles, pursuant to the provisions of the Nevada Revised

Statutes, and respectfully moves this Court for the recusal of Judge Scott Freeman, and in

support thereof, states as follows:

INTRODUCTION

This action was filed in the Washoe County District Court to address alleged violations of the Nevada Constitution Articles 1, 2, 15, and the Voter's Bill of Rights, malfeasance, malpractice, and nonfeasance by the Defendants under NRS 283.440 Removal of Officers.

FAILURE TO ADHERE TO STATUTORY TIMELINES

The Nevada Revised Statutes (NRS 283.440) mandates that citations must be issued within a timeline of 5 to 10 days upon the filing of a complaint. As of this date, 12 days have elapsed since the filing of the complaint, and no citations have been issued, representing a clear departure from the statute's requirements and depriving Plaintiff of his right to due process.

LACK OF COMMUNICATION

In an attempt to address this delay, the undersigned has made diligent efforts to communicate with the Court. Despite leaving three voicemails and sending three emails, the Judge and the Judicial Assistant have not provided any response, depriving the Plaintiff of the right to timely, effective communication, and due process.

FAILURE TO ADDRESS MOTIONS

The Plaintiff has duly filed a Motion To Compel Court to Issue Citations, that has not been addressed. Plaintiff has filed a Motion to Change Venue due to apparent biases and conflicts of interest. As of this date, the Court has not addressed or ruled on these motions, further delaying the resolution of the case and hindering the Plaintiff's right to a fair and timely hearing.

CONFLICTS OF INTEREST

It has come to the Plaintiff's attention that Judge Freeman maintains both personal and professional relationships with the Defendants. Such relationships create an apparent conflict of interest and raise concerns about the impartiality of proceedings under the current jurisdiction. Additionally, it has come to the Plaintiff's attention that the Defense, Judge, and Defendants have been closely working together regarding this case, further showing the appearance of impropriety.

REQUEST FOR RECUSAL

Due to the aforementioned reasons, which suggest bias, potential conflict of interest, and failure to adhere to mandated procedures, the Plaintiff respectfully submits that the integrity of the judicial process requires Judge Freeman's recusal from the instant case.

WHEREFORE, the Plaintiff respectfully requests:

That Judge Freeman recuses himself from the above-captioned case.

That this case be reassigned to another judge devoid of the biases and conflicts described herein and immediately address all the unaddressed motions Plaintiff has filed.

For such other and further relief as the Court may deem just and proper.
