27 The matter before the Court is the Plaintiff's Motion for Leave to File and Motion to Set Aside
Order Granting Defendants' Motion for Attorney's Fees and Costs. Upon consideration of the

is hereby **ORDERED**:

7 **Stay on All Orders and Enforcement Actions:** All orders and enforcement actions related to
8 the collection of attorney fees and costs are **STAYED** pending the final decision of the Supreme
9 Court on the Plaintiff's appeal.

12 **Review of Unaddressed Motions and Oppositions:** This Court shall promptly address the
13 Plaintiff's previously filed Motion to Stay Enforcement of Judgment Pending Appeal and the
14 Opposition to Defendant's Motion for Attorney's Fees and Costs.

17 **Grant of Oral Argument:** Pursuant to Rule 3.12 of this Court, the Plaintiff's request for an oral
18 argument to defend their position is **GRANTED**. A hearing will be scheduled by this Court for
19 such arguments to occur at 885 E Musser St, Carson City, NV 89701 Department 1.

21 **Further Orders:** This Court may issue further orders as necessary to enforce the terms of this
22 order or as justice requires.
