Dear Washoe County School District Board of Trustees:

I write to express my concern, anger and disappointment with the actions of Trustee Jeffrey Church; those actions endanger the mission of our schools and the ability of our children to learn. They also further harass and intimidate District employees who were brave enough to come forward about inappropriate behavior by a man in a position of power.

Instead of working collaboratively as a Board to help our students, one Trustee, yet again, is forcing the District to waste time and \$500,000 of taxpayer money to address his vindictive, personal grudges. \$500,000 to defend the District against yet another lawsuit and the threat of future lawsuits, all from one person. I encourage the Board of Trustees to condemn the actions of Trustee Church in the strongest possible terms and to show Washoe County parents and taxpayers that the Board of Trustees is committed to helping our children, not wasting time on baseless lawsuits.
