I entered the Washoe County Registrar of Voters lobby, at 1001 E 9th St. A 135, Reno NV, on May 28, 2024 at 8:40am. I observed, through the public observation window in the Registrar of Voters lobby, a man sitting at a workstation computer in the Ballot Tabulation Room, remove a white thumb drive and walk out of the room. The following is my detailed observation and a statement describing my conversation with George Guthrie, Washoe County Media Production Specialist.
Michael Mulreany was sitting at a computer workstation near a tall black technology cabinet and near a large white pillar on the left side of the room, under a clock. He was wearing a black jacket. I observed through the window for about 15 minutes while Mr. Mulreany sat at the computer station and appeared to be viewing the workstation monitor. He then removed a white device from the workstation that looked like a thumb drive, stood up with the thumb drive in hand, turned his back to me, and then walked around the large white pillar and out of a door that leads to the processing room.
I went to the public information counter and asked Chris, a Washoe County Registrar of Voters associate, if I could speak to someone about what I had observed in the Ballot Tabulation Room. Chris said he would locate someone and after one hour George Guthrie came to the counter to speak to me. I recorded my conversation at 10:13am with Mr. Guthrie on my cell phone. I informed him I was recording the conversation.  an observer, was standing at the counter and she also observed and recorded the conversation, with Mr. Guthrie's knowledge, on her cell phone. Mr. Guthrie identified Michael Mulreany, a Business Technologist, as the man I observed in the room and he explained Mr. Mulreany was uploading the Pre Logic and Accuracy Test. Mr. Guthrie explained this was a project that is run a couple of weeks in advance to make sure "all Dominion Machines were up to spec whenever they are going out to a vote center a pretest to make sure they are all accurate." Mr. Guthrie explained that Mr. Mulreany was getting that report and sending the report to the Secretary of States Office. He explained Mr. Mulreany is one of the few people with access to that room. I asked Mr. Guthrie how Mr. Mulreany was transferring the data from the upload in the Ballot Tabulation room and he stated to me that "As far as I know, I believe we took the report out and then we sent that to the Secretary of State" He then stated it was most likely not sent through an email but through an upload system. I explained to Mr. Guthrie that I observed Mr. Mulreany remove what looked like a thumb drive out of the computer and walked out of the room with it. I asked Mr. Guthrie what that device was, and he stated to me, "That would have been all the data that was from our Pre Lat." He then confirmed to me the data from the Tabulation Room was on a thumb drive. He stated to me that the Tabulation room to his desk and emailed to the Secretary of State's Office.
It is my understanding that the election is in process, and nothing should be uploaded or extracted from the Ballot Tabulation Room at this time.
