

## Declaration of Rick Weible

Pursuant to 28 U.S.C Section 1746, I, Rick Weible make the following declaration.

1. I am over the age of 21 years, and I am under no legal disability, which would prevent me from giving this declaration.
2. I currently reside at [REDACTED].
3. I am a computer network engineer and data analysis expert with over 25 years of industry experience. Owner of a small computer consulting company, that has been in business for over 25 years providing compliance certifications, desktop support, programming, network management and security, web development and hosting.
4. I attended Election System & Software training in South Dakota in Jan 2024.
5. I am co-author of the Gold Standard Elections White Paper, published. Mar 2024.
6. I wrote and testified for a 2023 bill that was signed into law in South Dakota to improve logic and accuracy testing.
7. Overvote is defined as when there is a vote in excess of the number of votes allowed for a contest.
8. The logic and accuracy test performed on 5/22/2024 in Washoe County did not adhere to the requirements of the Nevada Revised Statutes (NRS) 293B.155 Section 1. *The tests prescribed by [NRS 293B.150](#) and [293B.165](#) must be conducted by processing a preaudited group of logic and accuracy test ballots so voted or marked as to record a predetermined number of valid votes for each candidate and on each measure, and must include for each office one or more ballots which have votes in excess of the number allowed by law in order to test the ability of the mechanical recording device or the automatic tabulating equipment and programs to reject those votes.*
9. The Washoe County Election Summary Report dated 5/22/2024 shows that there were no Overvotes cast during the testing, in any of the contests, all 28 races, a violation of NRS 293B.155, requiring the testing of votes in excess of the number allowed for the contests.
10. Undervote is defined as when there is either no selection of any option within a contest, or less votes than what is allowed for a multicandidate contest.
11. The logic and accuracy test performed on 5/22/2024 in Washoe County did not adhere to the requirements of the Nevada Administrative Code (NAC) 293B.090 Sub 3. (a) 3. *“No selection made” for each contest and ballot measure*”, based upon the report for Republican race for United States Senate Rep. where it shows no undervotes were tested, thus violating the requirement. (Appendix page 2 of 11)
12. The logic and accuracy test performed on 5/22/2024 in Washoe County did not use unique numbers for each option within each election contest on the ballot to determine that proper mapping took place during the programming, to ensure that votes were not flipped between options/candidates within each race.

13. In the Republican race for County Commission, District 4, 2 candidates have 12 votes for each of them, and 2 candidates have 24 votes for each of them, in this situation the testing failed to ascertain whether the programming lines up properly and that no votes would be flipped within each of the pairs.

14. In the School Board Trustee, District G At-Large contest 3 candidates have 94 votes for each of them, and 2 candidates have 188 for each of them, and another 2 candidates have 282 votes for each of them, in this situation the testing failed to ascertain whether the programming lines up properly and that no votes would be flipped within each of the sets of candidates with the same number of votes for them.

15. These violations of State Statute, Rule and common-sense testing procedures have destroyed the public's trust in the oversight of the voting systems. These reports show that the systems were not properly tested, and therefore cannot rely on the results of the election from the machines. It is my recommendation that a full audit/recount by hand be conducted to determine the accuracy of the election and to restore the trust of the voters in the election system.
